



FAMILY COMMITMENT TO CHRISTIAN EDUCATION AT TCA

In accordance with our family decision to enroll our child(ren) at Tacoma Christian Academy, we hereby agree to accept and promote the following responsibilities.

Christian Lifestyle: We understand that the standards of Tacoma Christian Academy require both parents and students to conduct themselves in a manner that brings glory to God. We will uphold the spiritual emphasis of TCA and model the Christian lifestyle in our home and our spiritual life.

Christian Conduct: We will faithfully support the school through our prayers and positive attitude. We will share any complaints, questions or negative comments with ONLY the people involved (administration or faculty), and NOT around our child or other parents/families..

Academics: We will support the high academic standards of the school by encouraging and supporting good study habits and by giving our child(ren) the appropriate amount of help to complete homework, memorization, and projects on time.

Annual Auction: We agree to participate in the annual school auction by (1) donating items and volunteering on the auction team OR by (2) paying the opt-out fee \$350.

Attendance: We agree to support, participate, and attend parent- teacher conferences, school performances, and other mandatory school events that may be scheduled after regular school hours. We agree to bring our children to such events when required by school policies.

Discipline: We agree with the standards of conduct and discipline established by TCA and grant authority to the teacher and administration to discipline our child when necessary. We further agree to support the school and cooperate by disciplining our child at home.

Finances:

- We agree to meet all financial obligations promptly. We understand that our failure as parents' to comply with TCA financial policies and obligations will forfeit our child(ren)'s privilege to attend TCA.
- We understand that a withdrawal penalty (20% during first semester and 10% during second semester) will apply for any withdrawal reasons.
- If legal action is required to collect tuition, the undersigned parents will be responsible to pay attorney fees.

Liability: We release TCA staff from all liability, except negligence, while our child(ren) are under school care and responsibility.

- We understand that we need to have our own medical and major accident insurance to cover any emergency situation during school hours at the church facility and school-related events. We give permission to the school authorities, in case of emergency, to obtain medical treatment for our child(ren) in our absence. We will keep the school informed in writing of any changes in health or medication which may affect our child(ren) in school.
- We take responsibility to pay for damage to the facility or school property caused by our child(ren).

Placement: The school has full discretion in the placement of our child(ren) in the appropriate grade, class, and campus.

Volunteerism: We understand that in order to keep TCA's costs to a minimum, each family is required to complete thirty (30) service hours per year; a single parent home is required fifteen (15) hours per year. In case of service hours' incompleteness, we agree to pay off the remaining hours at \$10 per hour.
